

Policy Regarding Response to Allegations of Sexual Abuse of a Minor or Vulnerable Adult

The Diocese of Fort Worth is committed to eradicating the evil of sexual abuse of minors and vulnerable adults. When any allegation of the sexual abuse of a minor or vulnerable adult is received by the Diocese of Fort Worth, diocese officials immediately report the information to civil authorities (e.g., law enforcement or Child Protective Services). The diocese then takes steps to investigate the allegations (separate from any investigation by the civil authorities) to immediately determine whether the alleged incident is plausible (i.e., confirm whether the accused and accuser were in fact at the parish/school at the alleged time, etc.). If the allegation is found to be plausible, then the accused is immediately removed from ministry while the diocese conducts a further investigation to determine whether there is reason to believe that the sexual abuse of a minor or vulnerable adult occurred. The bishop of the diocese, in consultation with the Diocesan Conduct Review Board, makes the determination whether there is reason to believe that the alleged abuse occurred. The bishop is advised on this decision by the Conduct Review Board, which is a confidential consultative body composed mainly of lay members of outstanding integrity with good judgment who come various backgrounds and areas of expertise. A determination that there is "reason to believe" that the alleged abuse occurred is not a definitive finding that it actually occurred. Rather, it is a lesser standard (i.e., requires less evidence) than that required by our civil or criminal legal systems that, if met, impels the diocese to remove the accused from ministry permanently, unless the accused is subsequently cleared by the facts.

The Diocese of Fort Worth is fully committed to complying with the Charter for the Protection of Children and Young People and to fulfilling its moral obligation to protect our children and the vulnerable.
